Method of Bidding will be as follows:

LUMP SUM CONTRACT consisting of all work necessary to construct a 14-foot diameter by 92.6 foot tall; 106,000 gallon bolted, glass-fused to steel ground storage standpipe, complete with foundation; site grading; access road; telemetering equipment vault; site piping; disposal of excess excavated materials; site fencing; 430 feet of 12 inch diameter water main, electrical service and other incidental work to provide a complete, operational water storage tank and other appurtenances necessary to complete the **GRANGER HILL ROAD WATER STORAGE TANK**

The Cost Estimate is \$ 600,000.00

Bids will be accepted from only those Bidders who are Plan Holders of Record and obtain Documents from the Engineer's office.

The Owner reserves the right to waive any informality or to reject any and all Bids.

Each Bidder must submit with his Bid, security in the amount, form and subject to the conditions provided in the Instruction for Bidders.

All work done under this contract shall be subject to all Federal Davis Bacon Wage rates and rules.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity.

All Contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, Contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

The Contractor shall not discriminate on the basis of race, color, national origin or sex in the performance of this contract. The Contractor shall carry out applicable requirements of 40 CFR Part 33 in the award and administration of contracts awarded under EPA financial assistance agreements. Failure by the Contractor to carry out these requirements is a material breach of this contract which may result in the termination of this contract or other legally available remedies.
