SIGN PLAN APPROVAL CONDITIONS

1. Submit one fully completed Sign Plan Approval Application and **THREE** copies of drawings (plot plan and sign detail).
2. Plot plans shall include the actual size, shape, and dimensions of lot, and the distance from property lines to all buildings and signs.
3. Sign detail shall include the size/height of sign in elevation, and details sufficient to describe the construction of the sign and show conformance to the current version of the Ohio Building Code.
4. The signage package must be signed and sealed by a design professional registered in the state of Ohio, unless other arrangements (COSA) have been made with the Building Official.
5. All electrical work must comply with the current adopted version of the National Electric Code (NEC).
6. If the sign is to be on a state highway, provide Approval by the Ohio Department of Transportation.

Multiple signs (four or more), call for pricing.

1. Signs and canopies require a separate plan approval application.
2. Cantilevered awnings and canopies square footage is determined by area of frame attached to walls.
3. Column supported canopy fees require standard Plan Approval Application and fees.

ALL SIGN SUBMITTALS REQUIRE THE FOLLOWING:

The application shall be accompanied by the written consent of the owner or lessee of the premises upon which the sign is to be erected.
