

## LEGAL NOTICE

Sealed Proposals will be received by the **Muskingum County Commissioners**, Muskingum County, Ohio until **11:00 A.M.** local time, **February 4, 2021**, for furnishing all the necessary labor, materials, equipment, tools, and services for the construction of **“Maysville Avenue Sanitary Sewer Improvements”**, hereinafter defined as the Project, all as set forth in the Contract Documents now on file in the office of the Consulting Engineer hereafter named. At the time above mentioned and at the office of **Muskingum County Commissioners, 401 Main St., Zanesville, OH 43701**, said proposals will be publicly opened and read.

The Project includes, but may not be limited to, the following major items:

- Demolition / Abandonment  
(Septic / Surge Tank)
- (3) manholes complete
- 283 lineal feet of directional drill  
8-inch sewer
- 212 lineal feet of directional drill  
or open trench 8-inch sewer

Actual estimated quantities for the above items and all other items for the project are listed on the Proposal forms.

The Engineer’s Estimate for this project is **\$ 107,315.00**.

All Proposals shall be submitted on the Proposal blanks contained in the contract documents furnished and shall be sealed in an envelope and marked as follows: **“Maysville Avenue Sanitary Sewer Improvements”** and mailed or delivered so as to arrive at the office of **Muskingum County Commissioners 401 Main St., Zanesville, OH 43701**, prior to the above deadline.

A pre-bid conference will be held on **January 27, 2020 at 9:30 a.m. (local time)** at **Muskingum County Water Department, 375 Richards Rd., Zanesville, Ohio 43701**. Bidders are encouraged to attend the pre-bid meeting.

refundable cost of printed Bidding Documents is **\$65.00** per set, payable to Muskingum County Treasurer, plus a non-refundable shipping charge. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Each Bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in bond form shall be issued by a Surety Company or corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested herein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed no later than **May 28, 2021**.

Bidders must comply with the prevailing wage rates on Public Improvements in **Muskingum County** as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, (614) 644-2223.

Each Bidder must insure that all employees and applicants for employment are not discriminated against because of race, color, religion, sex or national origin.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The **Muskingum County Commissioners** hereafter defined as the Owner, reserves the right to waive irregularities and to reject any and all Proposals, to increase or decrease or omit any item(s) and to award to the lowest and best qualified Bidder. Each Proposal must contain the full name of every person or company interested in the same.
