 - o Bishop Parker said there will be LED lighting
 - Supervision and security
 - Cameras
 - Fencing
- Is the intent to serve Muskingum County and not advertising as a "Homeless Camp"?
 - o The purpose is to get people back on their feet with a mind to work
- What is the budget?
 - o Contractors are working on quotes now

The Commissioners will discuss further and take under consideration.

Judge Maria Kalis, Wendy Roush, Jason Baughman, Lucretia Frame, Robert Moore and Scott Lee all gathered with the Commissioners at Judge Kalis' request to discuss some maintenance issues with the Board.

- Elevator
 - Someone got stuck and the call box number went directly to Schindler, the elevator company
 - That has been resolved and the call now goes directly to Sheriff dispatch
- HVAC
 - o They have problems with the building staying warm enough
 - Scott said new controls have been ordered
- Roof Leak
 - o Scott is trying to stay on top of that
 - He says it is sometimes hard to find the spot that is leaking because of the composition of the roof
- Duct work and Carpet Cleaned
 - o The Board okayed, but asked if new flooring should be considered
 - Flooring is original and over 20 years old

Commissioner Crooks reported that she talked with Ashley Cook at the Chamber of Commerce regarding the lighting of the Courthouse.

Robert Moore, IT Director, came in to ask about the flooring in his department in the Hixson Building. He was also told to get estimates for new flooring.

There was further discussion regarding the Brush Creek Township concern regarding the trash dumping.

- Commissioner Crooks reported on the Health Department's response regarding dumpsters being made available to the individual, for the trash
- There was also discussion regarding a County Clean-Up Day, involving the Townships
- Commissioner Cameron reported that Michael Reiter stopped in last week to talk about Collection Days
 - o Michael said that Appliance Day Drop-Off at OUZ last year was difficult. He believes it will work out fine at our Recycling Center
- Commissioner Bell agreed to call the resident affected by the trash dumping and explain his options

Commissioner Bell will also follow up with Mr. Heckmann regarding his request for a Fourth of July event near the Homestead on Old Raiders Road.

After further discussion and information received that there will not be State legislation on the May ballot, it was agreed to not file the electric and natural gas aggregation for the May ballot.
