Commissioner Cameron reported on an email from Congressman Balderson's Office Friday regarding the Community Projects Funding. Don Madden, Zach Forker and Eric Reed will discuss later today when they come to session.

Kate Martin, a Tri-Valley High School Junior, came to talk with the Commissioners with an interest in interning part-time in the Commissioners' Office for a couple of months before summer break. The Commissioners agreed that no back-ground check would be necessary because of her age. Pam Davis, Human Resources, was also present for the meeting and will check with bookkeeping/payroll for the best way to hire Kate.

Mayor Don Mason came to discuss the operating of the Lorena.

- Mayor reported that he received additional information from Bill Page last night via email
 - o He has changed some of his requests/requirements to be the Captain of the Lorena
 - One of the Mayor's concerns is that the Visitor's Bureau is not open on Fridays. He feels being open until at least 5:00 p.m. on Fridays is critical
 - Commissioner Cameron doesn't feel we, as County Commissioners, can tell them they have to be open on Fridays
 - o Commissioner Crooks would question if the amount of time spent on operating the Lorena makes it worthwhile
 - O Commissioner Crooks said that in her conversation with Kelly Ashby, Kelly said she was willing to run all the revenue and expenses through the CVB Board. But, if at the end of the year they are out of money, she wouldn't want to have to go to her Board and report a loss.
- Commissioner Bell made the point that if the City is not willing to split the cost 50 50, then that would be the end of any discussion.
 - o Mayor said he would have to take to City Council

There was discussion with the Mayor regarding the possibility of the City combining their jail facility with the County.

 - O The recommendations from Pat Kelly, Scott Lee and James from Avondale is natural gas
 - Lead time for diesel is 40 weeks; lead time for natural gas is 62 weeks
 - o Pat Kelly said he is working on the HVAC design, but at present no plans are ready
- Cleanface
 - Eric asked if building fees could be waived for this project and the following was considered:
