The Clerk reported that Carolyn Hughes, Humane Officer, called her back regarding the financial grant towards the cat issue.

- Theresa Hildebrand never called back, so Carolyn asked that the check be made out to her
 - The Commissioners are not comfortable with that and would rather that the payment be made to the Humane Society for audit purposes
 - o The Clerk will call and explain to Carolyn

Commissioner Cameron reported that she did call Cole Graham from Shelly and Sands about today's meeting with ODOT, since they are contractor for the project.

• He said thanks for calling, they might be here, but if not, don't take personally and they could come another time

Commissioner Cameron reported that Captain LeCocq stopped in today to drop off Mid-East contract today and reported that the situation at Licking View with the trash and trailer is nearly all cleaned up and gone except for a few tires.

- Captain is going to call Steve Dillon about the tires
- Captain also said that the owner was previously in the City jail for violations against zoning on houses he owns in the City

Commissioner Crooks reported that Bear Davis from Pae Ohana called her Thursday saying he had some questions about the contract.

- She's not sure how he got the contract
 - O She hasn't even read it yet

- o The Commissioners have not discussed to any degree
- He had concerns that there was no price in the contract
- She explained that it would be Commissioners' decision
- A meeting is scheduled for 3:00 this Thursday afternoon

The Clerk reminded the Board about the letter from Andrew Johnson from CCAO regarding pictures from County fairs for their online magazine.

The Clerk reported that Jeff Jadwin told her it was his understanding from Mark Zanghi, that the August 3 meeting regarding I70 hazardous spills and future handling of accidents on I70 during construction should be advertised.

- Commissioner Cameron is wondering if he thinks it needs to be public since the media was told about it
- Jeff said he received a call from Ron Strong at WYBZ about the meeting....he didn't know how they found out about it
- Commissioner Porter said, for the record, he didn't talk to the media
- Commissioner Porter reported that there will be a representative from Perry Township Fire Department at the meeting
- It was decided to invite all Fire Departments
- In comparison, the Washington Township JEDD meeting was not advertised
- Commissioner Crooks says this is not our meeting; It's an EMA meeting

A call was placed to Mark Zanghi regarding the advertisement of this as a public meeting

- EMA is not a public body
 - o Commissioners are not making decisions, just attending
- Do we owe the media anything to have them be involved
 - o Under no obligation to let them know; EMA is having a meeting
 - o Should be no concern whether the media is there or not

Stan Lucas, Sewer Department Manager, came to talk with the Commissioners regarding tap fees.

- Currently, on the top end for industrial users, it can be very high
- He would propose this amendment:
 - For an Industrial User with flow larger than 20 Benefitted Units the connection fee will be \$97,000 plus \$485 for each additional Benefitted Unit
- Commissioner Porter asked if that would allow us to cover our costs
 - Stan said we will do okay
 - He feels better off lowering tap fees to bring in businesses
 - It will also generate \$24,000 per month revenue for the Sewer Department and jobs and taxes for the County
 - Commissioner Porter asked if Stan had researched how many businesses have already had tap fees forgiven to get the business here, you'd be surprised
 - Stan does not know
- Stan hopes this will provide a better opportunity for potential businesses
 Commissioner Crooks mentioned Chad Bay's exit interview

- Every Commissioner has a copy and Stan was given a copy Stan asked if anyone had heard anything from or about Dunfalls
- Mark Zanghi is still wanting to talk with their attorney, Grant Stubbins Commissioner Porter asked Stan if he is getting engineering above and beyond what currently thinking
 - Stan said meeting with Don Madden, Projects Department, to talk about creating list of potentials
 - Stan is hoping that he and Don can come in Monday to present list

Commissioner Porter said he had asked Pam Davis, Human Resources, if a single Commissioner can discipline an employee

- No it takes a majority of Commissioners
- He would have disciplined Jeff Jadwin for the way he talked to him at last Thursday's meeting

A call was placed to Don Madden regarding Tom and Jeff Roberts' request for water on County Line Road

- Commissioner Cameron understood that an application was the first step
- Normally, Don would say a petition would be the first step
 - o But, if the Roberts want to file an application as part of the process, that is fine
 - o Application must be filed by landowner
 - Neither Jeff nor Tom Roberts are landowners; it's the dad and uncle
 - Currently, Don has a map with responses for water for a much larger area;
 all of Flint Ridge and coming around Mt. Sterling

Back to EMA meeting, August 3

- Commissioner Cameron said it doesn't matter to her about advertising
- Commissioner Crooks' understanding from Mark is that Jeff is calling the meeting; it's his meeting
- Commissioner Cameron thinks the whole question came up because the media called Jeff and started asking him questions about the meeting
- A call was placed to Jeff to tell him that Mark said he is under no obligation to make the meeting public
 - o EMA is not a public entity
 - The Board does think that other township fire departments should be invited
 - Jeff will contact other fire departments

Commissioner Porter pointed out that in the July 22 minutes Jeff Jadwin accused Mr. Mahon of providing pictures to Jerry Sode of AlTowing of the I70 Hazardous Waste spill.

• It was not Mr. Mahon, it was B & H Towing

- Avondale's maximum population is 22
 - o 28 staff members
- Very appreciative of levy; 45% of 2020 revenue
- The Sidwell Foundation and the Shelly Company have contributed to great improvements in the facility
- Comfort and well-being of kids is top priority

Jason distributed a spreadsheet explaining the upcoming projects for Muskingum County. The I70 project kicked off last week and will run from SR40 to SR93

- This project will include 16 bridges and take approximately seven years to complete
- Work will take place mostly at night
 - Sunday night through Thursday night
 - o Will work days when possible
- Updates on this project are available on the ODOT Project Page
- Commissioner Porter asked why three lanes were not considered for this project
 - o Right of Way is tight
 - Part of why this is such a long project

The Mayor asked about the narrow curve bridge on SR666

- He questioned purchasing property to eliminate the one lane and the difficult, blind curve
- Mark Eicher said he has looked at the façade, which is still in tact
- Jason will look into the situation

The Mayor also brought to attention the Putnam underpass

- Large trucks should be using Wayne Avenue to SR719
- Google/GPS doesn't always take them Wayne Avenue
- Very difficult to transition grade separated to grade crossing
 - o Working with railroad can be challenging

Clint Cameron asked the Mayor about the lights on Underwood

- Always backed up
- Can the right lane arrow be made longer
- The Mayor wouldn't be surprised if people start using Old Adamsville Road instead of SR40 when the I70 ramps are closed

The Mayor reported that he is hopeful to begin Dug Road construction by March It was agreed for ODOT to provide routine updates to the Commissioners

- Before major traffic changes
- Morgan suggested adding links to our County and City websites to update public

The Mayor had texted Commissioner Crooks during lunch and said that Matt and Kade, on his staff, would be willing to help the County with the ARPA money.

 - Commissioner Cameron asked if we can see those affidavits
 - o Pam said she would bring them in

 - Pam said that the attorneys for both sides had access to all affidavits
 - o But she has not seen what Mr. Nelson submitted
 - Commissioner Cameron asked if it possible to see what Mr. Nelson submitted

 - It wasn't based only on affidavits, Pam had to submit Mr. Nelson's Discipline files, Personnel files, Insurance files...everything
