Minutes for July 27, 2020

Commissioner Crooks reported that she talked with Don Madden regarding ASK Services for the EastPointe Water project. She asked him if he was comfortable with ASK Services being awarded the bid. Don agreed that he has no problem with his work as far as what he has done for the Water Department, but his paperwork is terrible. Don didn't seem to have a problem awarding the bid to ASK Services. Commissioner Porter understands that he has hired someone to help him with his paperwork.

Commissioner Porter asked about interviewing all three Dog Wardens. Commissioner Crooks said that only two would be interviewed initially, then have discussion about what the next steps are.

There was discussion regarding the reply from Gloria Brown, Director of Rambo, addressing the Assistant Receptionist position she had requested. The following was then considered:

RESOLUTION 20-0658 approve the hiring of a Receptionist's Assistant for the Rambo Memorial Health Center/Muskingum TB & Respiratory Clinic, through Action Temporary Services, for forty hours per week for up to an eight week period (September 14, 2020 through November 06, 2020.

There was brief discussion with Pam Davis, Human Resources about COVID traveling policies. Commissioner Porter asked what the current County policy is.

- Pam is still waiting on a return call and determination from Ben Albrecht about self-quarantining and the use of COVID sick time

Commissioner Crooks reported that she took a call from The Salvation Army inquiring about paperwork for the CARES Act monies. She advised them to contact the City, since the local Salvation Army is located in the City.
