- Debbie reported that for the October report they are asking for a listing of potential projects with dollar figures
- She would like for Todd (Treasurer) to share the portal information with her, that would help with her reporting
- Debbie is creating a spreadsheet with information from all Ohio County Auditors, that shows what type of projects they are using ARPA monies for
- It was suggested that Eric watch informational webinars with NACO (from US Treasury) and OBM (Office of Budget and Management)
 - o Also, would be good for him to spend time with Jennifer Wilson in Bookkeeping and Stephanie Spencer, Chief Administrator
- New Water and Sewer Funds will be set up separately for ARPA funding

Debbie would like to use the back office in the Projects Department for her appraisers to meet with folks about the new property values

• Two weeks; October 4-15

Debbie reported that she has had two unexpected retirements that will have an effect on her budget, due to payouts.
