All agreed that they would attend. The Clerk is to verify at which Oaks he is a resident.

The Clerk is to notify ODOT that they will not be participating in this week's IR-70 update.

Carmen Boyd came to talk with the Commissioners about Childhood Cancer Awareness Month for September.

The Commissioners presented her with a proclamation and the Courthouse will be lit "gold" for the month of September.

The Commissioners adjourned for lunch to resume session at 1:30 p.m.

Pam Davis, Human Resources and Stan Lucas, Sewer Department Manager, came to talk with the Commissioners regarding their updated Pay Scale.

The following was then considered:

There was also discussion with Pam and Stan regarding CDL requirements.

- Are we going to try to send them through the training during their first six months?
 - o Or would we consider extending their probationary period up to a year
 - o Pam discussed with Jeff Stankunus' office who said you can have different probationary periods for different classifications
- Concerns include paying for an employee's CDL training and then they leave the County.
 - We could try to hold them to an agreement to stay or pay it back, but Jeff said that you can try to take something out of their last check, but you have to make sure it still results in them making minimum wage
- Will the County receive any kind of discount for supporting the CDL program at Mid-East
 - o Stan said that email to Eric said, in a "politically-correct" way, No special treatment
 - o Commissioner Crooks said she agreed to give them the money with no strings attached, good for the community and economy
 - o Commissioner Cameron said her vote was not attached to getting anything special from Mid-East. She understands an email from them to say that they could compromise on the class size.
- Commissioner Porter thinks that we should keep the Probationary Period at 180 days knowing that we can extend it if we need to.

It was agreed to keep the Probationary Period as is.

Stan presented an estimate from Enviro-Flow Pipe for Union Street in South Zanesville in the amount of \$14,267.00. All agreed. Work should start next week.

The Clerk left for an appointment at 2:05 p.m. and Beth Iden, Deputy Clerk, stepped in.

Pam Davis, Human Resources, discussed the .60 cent rate increase for Danny Brenneman during his probationary period ending Oct. 22, 2022. The Commissioners agreed to wait and discuss after his probationary period is over.

Pam stated that the fair ground hail claim checks were made out to the Commissioners instead of the fair board. Pam will ask Stephanie Spencer how to proceed with handling the checks.

Commissioner Crooks addressed an email from Sheriff Lutz.

Sheriff asked if the Commissioner were opposed to leaving the adoption fees lowered in hope of having more adoptions.

Commissioner Crooks and Commissioner Cameron were in agreement to keep them lowered, if it helps in adopting the dogs. Commissioner Porter said Sheriff Lutz is the dog warden.

Sheriff asked if there was any further discussion on moving Seth to 40 hours a week at the Adoption Center.

Commissioner Crooks is in favor

Commissioner Cameron is in favor, but would rather he not go over 40 hours too often Commissioner Cameron asked if the new girl had started yet.

Sheriff Lutz asked the Commissioners if they want to wait for a signed agreement from a local bank regarding funding the coverings for the outside kennels and landscaping before they proceed with the project.

Commissioner Crooks made a motion to spend the \$62,000 on mesh fronts on as many kennels as allowed at the K-9 Adoption Center

- Commissioner Cameron is not in favor and just wants that project to be done and
 for us to move on with something else and for us to quit continue spending
 money there. The project to be done, the contractors need to move out and we
 need to move on.
- No second, the motion dies.

Commissioner Cameron read an email from Tanner Kilpatrick, Mid-East training facility, replying to the question if customized hours are available for CDL tests. They do offer extended hours as needed.

Porter made a call to Jason Baughman, Building Inspector.

- Did you get a hold of James Teague and set up a meeting?
- Did you get a final inspection of the wash rack roof at the fairgrounds? Fee \$26.50

Commissioner Porter reported he received a phone call yesterday morning from Jerry Miller, Fairgrounds, that there is a water leak where the old line and the new line meet.

- Jerry stated that the Feeder Calf Roundup is next weekend
- Casey Hazen was notified and he came to inspect on Wednesday
- Casey could not find where the leak was
- Estimated \$8,000-\$9,000 for Hazen's portion of the work
- Talked with Don Madden, Project Manager, he has the 4" pipe
- Estimated \$3,000-\$4,000 stone
- Jerry said the area is dry this morning
- The fairboard members will decide whether to fill in or replace
- Commissioner Porter suggests repairing
- Stan Lucas, Sewer Supervisor, was called to put a camera in the line
- Commissioner Porter commented that Hazen did not cut line.... It was plugged
- Commissioner Porter told Jerry there are 2 options...use the \$9,000 towards it from the Cattlemans and come up with \$4,000 for the stone or fill it in.
- Commissioner Porter is waiting on 2 people and Hazen's is waiting to hear from the Commissioners on who will pay them for yesterday

- Commissioner Cameron said it is not the Commissioner's call to say to fix it, but Hazen should be paid for their time. Commissioner Porter agrees
- Commissioner Porter stressed to Jerry it needs an answer as soon as possible

The following legislation was then considered:

RESOLUTION 22-0919 approve, upon Fair Board's approval, to expend money needed for stone required to fill back-fill water line at the Muskingum County Fairgrounds. Motion made by Commissioner Cameron, seconded by Commissioner Porter.

Motion carried.

Commissioner Porter said Jason Baughman, Building Inspector, said Mr. Teague dropped off plans to be reviewed and things were going in the right direction.

Commissioner Porter called Jerry Miller regarding the Resolution the Commissioners passed paying for the stone for the water line down to the wash rack and that the Cattlemen's are paying Hazen to put in the line. The County is supplying the 4" pipe. He was told he will need to have an answer right away as to how they are going to proceed with the water leak.

Commissioner Porter sent a text to Mark Eicher, County Engineer, voicing his disapproval on how the two manhole covers were fixed on Sonora Road. Mark said that makes two of us.

Commissioner Porter said he was told that nothing has been said about the Commissioner's proposal as far as the restroom and the bleachers at the fair board meetings. Commissioner Cameron said it was her understanding that Eric hasn't talked to the fair board about it, yet.

Commissioner Crooks mentioned the email response from Mark Zanghi, Assistant Prosecutor, to her question about the Miracle League. Mark Zanghi said the Engineer is preparing a new legal description.

With no further business being before the Board, the meeting was adjourned at approximately 3:09 p.m. on the motion of Commissioner Cameron and the second of Commissioner Porter.
