There was brief discussion with the Sheriff regarding the possibility of a new jail.


- Sheriff mentioned that there are a couple of House Bills that give Commissioners the right to put sales tax on the ballot
 - Coshocton County did half a mill on the ballot, which passed, and will generate \$1,000,000 a year for 24 years
- Commissioner Crooks noted that feedback on the latest grant is that the ones that received monies had completed feasibility studies
- There was brief discussion regarding joining with the City jail
 - Sheriff does not think that will happen; City not on board
