Taylor, Case No. CR2020-0182); and

WHEREAS, the Entry granting forfeiture of the real property to the Board of County Commissioners, Muskingum County, Ohio is recorded at Book 2940, Page 411 of the Official Records of Muskingum County, Ohio; and

WHEREAS, Dwight Taylor entered into a Lease Agreement with Option to Purchase the real property located at 2425 Three Towers Road, Chandlersville, Ohio 43727 on or about August 30<sup>th</sup>, 2018 with Richard and Ashley Marshall; and

WHEREAS, this Board of County Commissioners, Muskingum County, Ohio adopted Resolution Number 21-0411 on April 22, 2021 authorizing Amendment No. 1 to the Lease Agreement with Option to Purchase; and WHEREAS, Richard & Ashley Marshall, pursuant to the terms and conditions of the Lease Agreement, have elected to exercise their option to purchase the real property located at 2425 Three Towers Road, Chandlersville, Ohio 43727; now
